**[PROPOSED] ORDER AUTHORIZING
DISBURSEMENT OF SETTLEMENT PROCEEDS**

This matter coming before the Court on the Unopposed Motion of the State of Illinois to Authorize Disbursement of Settlement Proceeds, and the Court being fully advised, the State's Motion is hereby GRANTED, and the Court ORDERS as follows:

1. Pursuant to 740 ILCS 175/4(d)(2), out of the \$33.6 million in proceeds to the State from the settlement of the above-captioned action (excluding Relator's share), the Court awards and authorizes the State to disburse such proceeds, as follows:

- a. Bloomington-Normal Airport: \$41,342
- b. Chicago Board of Education: \$2,873,520
- c. City of Champaign: \$25,009
- d. City of Chicago: \$12,524,822
- e. City of Oak Forest: \$255,197
- f. County of Cook: \$2,041,577
- g. Community High School District No. 111: \$61,247
- h. Illinois Housing Development Authority: \$1,106,943

- i. Illinois International Port District: \$76,559
- j. Illinois State Toll Highway Authority: \$8,111,697
- k. Regional Transportation Authority: \$755,945
- l. Rock Island County Metropolitan Airport: \$13,934
- m. State of Illinois: \$3,062,366
- n. United City of Yorkville: \$62,294
- o. University of Illinois: \$1,465,393
- p. Village of Bartlett: \$47,160
- q. Village of Bolingbrook: \$45,323
- r. Village of Crestwood: \$177,311
- s. Village of Davis Junction: \$35,728
- t. Village of Hoffman Estates: \$333,798
- u. Village of Montgomery: \$102,079
- v. Village of Schaumburg: \$76,559
- w. Village of South Barrington: \$23,478
- x. Village of Western Springs: \$280,717

2. The State shall continue to work diligently to collect all information necessary to effectuate the transfer of funds to the issuers identified above and shall transfer funds consistent with this Order.

3. If, six months after the entry of this Order, the State has not received information necessary to process and transmit any Settlement Funds to any parties otherwise entitled to payment as shown above despite diligent efforts to reach such parties, the State may disburse the

Settlement Funds that would have been due to that party into the Illinois General Revenue Fund instead of disbursing Settlement Funds to that party.
