# Agenda item 1: FY2024 Purchase of Subscription to Facilitate Control of Technology and Security Environments

Eileen Baumstark-Pratt, OAG Purchasing Office (OAG PO) stated that the Chief Technology Officer submitted a request to purchase the Cloudflare Enterprise Service Plan for 3 years. This will help IT control the OAG's technology and security environments by reducing complexity and improving visibility across these environments on premises, on public cloud SaaS, and on public internet domains.

Cloudflare Inc. is available through the NSAPO Cloud Solutions master contract through SHI (AR2488). A Purchase Order with SHI will be executed in the amount of \$145,373.91.
